There are risks that accompany all aspects of life as well as Shooting Sports. Some of these risks are inherent in the activity; some are changed, increased or decreased due to the activities of TWF. You must understand and accept all the risks of the activity, inherent and others.

Kids enjoy life. In that process kids fall down, get back up and keep having fun. Sometimes though a kid might not get back up as quickly or bounce back as fast. As you, a parent well know, there is no way to prevent a child from falling down or getting hurt. TWF will do the best job we can to help your child bounce back and enjoy the activity. However you need to acknowledge and understand that no matter how many staff or how much work we do, sometimes a child can get hurt.

Any activity involving rifles, shotguns or other firearms runs the risk of an accident. Before allowing your child to attend any event, prepare your child by going through the safety issues you expect your child to know and understand when working with firearms. Make sure your child knows how the firearm will work, how it is to be loaded, carried, transported and handled. Parents:

Monroe County Shooters has also established the following contract in conjunction with and in addition to the TNSCTP Code of Conduct.

Coaches / Adult Volunteers:

1. I will exercise exemplary, professional behavior at all times. Behavior is a reflection of respect of myself, the program, and others, and also serves to present admirable role models for the participating youth.
2. I will observe the dress code.
 - a. Pants shall be fitted around waist (no sagging). Shirts will have sleeves and not cut up the sides.
 - b. Females: Midriffs and cleavage shall be covered
 - c. T-shirts will not decorated w/ vulgar, crude language/pics; no violence, drugs, or alcohol related slogans
 - d. Pants or modest length shorts are acceptable. Shorts must be no higher than 6 in. above knee.
3. I will use appropriate language.
 - a. Inappropriate language (swearing, "cussing", vulgar, crude, racist, sexist, etc.) is strictly prohibited.
 - b. Encouraging and affirming language shall be use.
 - c. Discipline shall not include shaming, humiliating, or berating, but will be instructive and constructive.
4. I will follow appropriate behavior.
 - a. Possession of alcoholic beverages is prohibited. Alcohol shall not be consumed prior to or during any TNSCTP activity by adult participants.
 - b. Tobacco use shall only be used in designated areas.
 - c. Illegal substance use or possession is prohibited.
 - d. Punctuality, professionalism, cooperation, respect for others, fulfillments of responsibilities, and a positive attitude are expected at all times.
 - e. Respect for the needs of fellow adults will be maintained during TNSCTP activities.
 - f. Inappropriate physical contact is absolutely prohibited. 5. I will adhere to the "two deep" approach of adult/youth interaction: two adults shall be present when interacting with any youth. There should never be one-on-one, private interactions between an adult and a youth.

6. I understand that head coaches are responsible for the actions of athletes, assistant coaches, adult volunteers, parents, and other individuals associated with the Monroe Co. Shooters team and will serve as the primary contact for the team. In the event that the head coach is absent from an event/function in which the team participates, an appointed assistant coach will serve as head coach for the designated time period.
7. I understand that all coaches and volunteers are required to complete and pass a background check. Results from the background check may prevent any person from serving as a coach/volunteer if deemed unacceptable by the TNSCTP Manager, TNSCTP Steering Committee, or the TWF.
8. I understand that as a coach/volunteer that I may be suspended or removed from participation in the Monroe Co. Shooters or SCTP for violation of any portion of documented rules including Monroe Co. Shooters, TNSCTP, NGB, or TNSCTP Code of Conduct Policies for adult and/or youth participants. Procedures for removal are outlined in the TNSCTP Policy and Procedures Manual.

Violations are subject to the following disciplinary actions depending on severity:

- Written warning by MCS Board of Directors
- Suspension or immediate ejection from the MCS activity/event
- Termination of MCS membership
